Location: Cooters Pond, Prattville, Alabama.

Registration: Opens at 4:00 a.m. day of tournament or Pre Register by submitting entry form and fee by mail or hand delivery in the front office of Hooper Academy by Wednesday, March 9, 2022.

Weigh-In: 3:00 p.m. for first flight, Maximum of four flights every 15 minutes.

1st Place \$2000

7TH \$150

This is based on 50 boats – pays one place (\$100) for every 10 boats above 50.

Big Bass is optional and 100% payback.

TOURNAMENT RULES

1. No live bait, trolling or jigger polling permitted. Only one (1) rod in use at a time.
2. Life vest will be on and fastened when big motor is in operation. Kill switch must be operational.
3. Each boat must have liability insurance.
4. Absolutely no alcoholic beverages allowed during the tournament activities and weigh in.
5. All teams must check in, even if they do not have fish. 12" minimum by Golden Rule. Five (5) bass limit per boat.
6. Payment of fee will be considered a commitment. However, partnership or even boat unit changes will be permitted with proper notification being made to tournament director. This may require completion and signing of a new entry form.
7. Registration the day of the tournament will be at 3:30 am. Boat inspection will be at the launch area.
8. 4 ounce penalty for each dead fish and a 16 ounce penalty for each undersize fish brought to the scales will be assessed. A tie will be broken by the greatest number of fish, then big fish, then flip of coin.
9. All live fish will be returned to the river.
10. A penalty of one (1) pound per minute will be assessed for late arrival to weigh-in. All contestants more than 15 minutes late will be disqualified.
11. Violation of rules, cheating, or unsportsmanlike conduct will result in disqualification from the tournament and forfeiture of entry fees. The decision of the tournament committee will be final and binding. **All contestants are subject to a polygraph.**
12. Rules and their interpretation are solely at the discretion of the tournament directors. Decisions are final.
13. Tournament Officials shall have the right to board any participating boat and inspect live wells, bait and equipment. All boats shall be inspected prior to launch. Protests shall be made in writing, within 30 minutes of weigh –in.
14. The tournament board of directors reserves the right to reschedule tournament in case of inclement weather.
15. Anyone that has fished the Elite Series within the last three years will not be eligible to fish in the Hooper Academy Bass Tournament.
16. **OFF LIMITS WATERS - past (above) the Bibb-Graves Bridge on the Coosa River at the Wetumpka Boat Ramp and past (above) the Boat Ramp at Fort Toulouse on the Tallapoosa River. Fishing beyond these points will result in disqualification.**
